The Complete Michael Jackson Story

Till Proven Guilty - His whole live Michael Jackson spends a huge part of his well-earned money to charity. Even the Guinness Book of World Records honors him for this fact. Most people are not aware of this, as most of the press has ignored this fact. Also Michael Jackson has been nominated for the Nobel Price for Peace twice already, again good news is deliberately ignored.

In 1993 Michael was accused of Sexual Child abuse. The public has never heard the defence of Michael Jackson, until now. It is, of course, not possible to prove that something did not happen. That's like you are trying to prove that an UFO did not land in your backyard....

What about the \$\$\$\$\$\$\$ money?

Due to various personal, professional and financial reasons last time Michael Jackson

was advised by his lawyers to settle the civil case (read why on page 2 in the 1993 article).

So the criminal case is their first and only option (at this moment in time).

You can imagine that after the criminal case they can still file a civil case against Michael Jackson. And let's not forget both the family as well as the prosecutors have been approached for some lucrative book and film deals.

What would you do?

If you believe your son was molested would you:

- a) Sue the person for money?
- b) Make sure the person goes to prison?

- 1) Civil case: Filed by an individual and is (always) about money. These cases can be settled out of court.
- 2) Criminal case: Filed by the State against you. This case can never be settled or bought.

The family in 1993 chose to file a civil suit. In other words, went for money.

The New accusers claim it is not about \$\$\$ because they go for a criminal case. You must know that a change in the law "with child abuse" people are prevented from filing a civil case before the criminal case is finished.

accuser, was caught on tape discussing a "devious, nasty, cruel" plan to "destroy" Michael Jackson.

- After unsuccessfully trying to negotiate a \$20 million screenwriting deal from Michael Jackson, Evan Chandler admittedly gave his son a memory-altering drug called "sodium amytal" (available in his dental office). Only after being given the drug did the boy accuse Michael Jackson of sexual abuse.

- Shortly after the alleged abuse was reported to the police, the Chandlers filed a \$30 million lawsuit against Michael Jackson. They were being represented by civil lawyer Larry Feldman.

- Michael Jackson requested that the civil trial be delayed until after the criminal trial was resolved. This was to ensure that the prosecution would not be privy to his entire defence strategy months before the criminal trial began. But Michael Jackson's request was

denied. This, among many other reasons, led to Michael Jackson's decision to settle the civil lawsuit. Waiting for the criminal case.

- The '93 accuser claimed to know exactly what Michael Jackson's private parts looked like. To prove his innocence Michael Jackson allowed Police to take nude photos of him. The story of the child and the pictures taken obviously did not match, otherwise criminal charges would have been filed against him.

- Documents about the settlement that leaked out on the Internet reveal that with signing the documents the accusing family dropped all 6 child abuse charges from their complaint. Michael Jackson only settled for one claim of negligence and denied any wrongdoing. The accusers agreed, and could still testify against Michael Jackson in the criminal case, as the settlement did not prevent this. But they didn't and they refused to further cooperate with authorities.

What did happen in 1993?

- Evan Chandler, the father of Michael Jackson's first

The NEW 2003 Case

- More than 400 witnesses were interviewed. The case was even heard by two grand juries, but no criminal charges were ever brought against Michael Jackson due to lack of evidence. According to one grand jury member who spoke to CNN in 1994: "No damaging evidence was heard."

- Tom Sneddon - who has had numerous lawsuits filed against him for malicious prosecution, conspiracy and civil rights violations - soon developed an obsession with Michael Jackson. He spoke about the Michael Jackson case to the press numerous times.

In an press conference held by Tom Sneddon we learned that due to the (failed) 1993 court case against Michael Jackson the law had been changed.

Art 288 has been extended with Art 288A, meaning that if you touch a child (if you put your hand on its shoulder for example) you are conducting a criminal activity. This new law also forces the children to testify, even if they do not want to. Tom Sneddon continually urged any victims of Michael Jackson to please come forward.

- In February 2003, the controversial documentary "Living with Michael Jackson" aired in the UK. A young boy appeared on the documentary and he told journalist Martin Bashir that he had once spent the night in the bedroom of Michael Jackson. Michael Jackson added that he had slept on the floor in a sleeping bag while the boy slept in his bed. After hearing about this, Tom Sneddon released a press statement saying he would tape and watch Living with Michael Jackson.

- A week later, the first accuser's deposition from 1993 was leaked on the Internet. Soon all of the principle players from the 1993 case, including Tom Sneddon, were making guest appearances, on several tabloid like television shows, where they spoke of old and unsubstantiated rumours about Michael Jackson.

- Due to the commotion accompanied by the airing of the documentary, both the 'Department of Children', the 'Family Services' as well the as the 'Santa Barbara County Sheriff Department' were asked to investigate Michael Jackson. The boy who appeared on the documentary, his mother, his

brother and his sister all denied any wrongdoing on Michael Jackson's part. They also said Michael Jackson had never been alone with the boy; there was always a third party present.

- The mother attempted to sue ITV/Granada television for featuring her son on the documentary without her permission. Her boyfriend also demanded money from Michael Jackson in return for the family's appearance on a rebuttal video that Michael Jackson was putting together. When this failed, the mother filed for an increase in alimony from her ex-husband and asked for her child support to be doubled. She then contacted lawyer Bill Dickerman with plans to sue Michael Jackson over a matter unrelated to child molestation.

- Eventually, the mother got in contact with Larry Feldman - the civil lawyer who helped the Chandlers get a \$15 million settlement in 1993 - and suddenly the child abuse allegations materialized. Feldman sent the boy to Dr. Katz, who was also involved in the 1993 case.

- Katz reported the alleged

abuse to the Santa Barbara Police Department and then Tom Sneddon personally investigated the accusations. It was then the family found out that because of the law that Sneddon had changed, their civil lawsuit would have to be put on hold until after the criminal trial was over.

- In November, Sneddon informed the family of a state victim's fund that would provide them with financial compensation if they went through with the criminal case. He met with the accuser's mother in an empty parking giving her the necessary paperwork to apply for the fund. Less than a month later, Michael Jackson was arrested.

- Although the accusing family made unsubstantiated abuse claims in the past, Sneddon charged Michael Jackson with 7 counts of lewd and lascivious conduct with a child under the age of 14 and 2 counts of administering an intoxicating agent.

- These alleged acts took place between February 7th and March 10th; it was during this time period that the DCFS and SBCSD investigations took place.

- By raiding the Private Investigator's office from the Michael Jackson attorneys, Sneddon was able to view Michael Jackson's defence evidence. After doing so, Sneddon took his case to a secret grand jury where he added and got rid of several charges against Michael Jackson. On April 30th, Michael Jackson was charged with 1 count of conspiracy, 4 counts of lewd and lascivious conduct with a child under the age of 14, 1 count of attempted child molestation and 4 counts for administering an intoxicating agent. According to the new charges, Michael Jackson allegedly conspired with five unnamed employees to kidnap the accusing family and force them into making positive statements about Michael Jackson.



- The dates of the alleged molestation in the original complaint (filed in Dec) are different from the dates in the indictment (filed in April)? Why did the accuser and his family change their story? Is the accusing family slightly confused or was this Tom Sneddon's way of saving his case? Almost a year later 60 police men again ransacked Michael Jackson's house for the fourth time in search of evidence? Don't they have their evidence by now? Stay tuned...



Things to wonder about:

- 1) If Michael Jackson would be guilty then would he invite a journalist to film him with a potential new victim?
- 2) When the bail was set for Michael the bail was set on 3 Million dollar. A murder suspect gets bail for only 65.000 dollar. The media constantly reports that Michael Jackson is broke. So why set the bail so high? Like there is a place in the world Michael Jackson is not known and he could run & hide?
- 3) If convinced your son has been molested would you go shopping for lawyers first or go straight to the police instead?
- 4) The mother recently got re-married to an ex-marine, co-incidentally also named Jackson. Would you like to be named after someone who supposedly molested your son?
- 5) A conspiracy can never be conducted alone. You need 2 or more people involved. Why do they only charge Michael?

More relevant facts:

- 1) Michael Jackson has the support of his entire family.
- 2) Michael Jackson financially supported the accusing family. Paying for the boys chemotherapy, their apartment, their car, etc. Only after Michael Jackson stopped the financial support they decided to turn against him.
- 3) The prosecutor Sneddon claimed to have dropped the investigation after 1993. However in 1999 he flew to Australia with a mission to interview several kids who had visited Neverland (Michael Jackson's home).
- 4) There is a gag order for people connected to the Michael Jackson case while the media can do whatever it likes and therefore influences the general public possibly even the jury.
- 5) Michael Jackson voluntarily turned himself in to the Police department. Apparently a man is not presumed innocent until proven guilty, as the police found it necessary to handcuff him. Only after paying bail, Michael Jackson was free to go.
- 6) The secretary of the 1993 prosecutor attorney is convinced Michael Jackson is innocent and wrote a book about it called 'Redemption'. Basically ignored by most media.
- 7) Monthly terminal ill children visit Neverland; hundreds (if not thousands) have done so. In interviews all these children defend Michael.
